(A). Transfer- Roadway and Right-of-Way to Jurisdiction of Alpine City.

RESOLUTION

Transfer of Portion SR-74 to Alpine City Utah County

WHEREAS, Section 72-4-102, of the Utah Code Annotated 1953, as amended, authorize the Transportation Commission, to approve deletions from the state highway system between general sessions of the state Legislature, and

WHEREAS, the Utah Department of Transportation having entered into a Jurisdictional Road Transfer Agreement between officials of the Utah Department of Transportation incumbent of the Region 3 Director, and officials of Alpine City, and

WHEREAS, all statements incumbent to the aforementioned Agreement entered into between the officials of the Utah Department of Transportation and Alpine City will become incorporate to this resolution, and

WHEREAS, the Program Development Division, having reviewed all provisions defined within the aforementioned Agreement concur with all statements incorporate to said Agreement.

NOW THEREFORE, be it resolved as follows:

1. Roadway currently residing as a portion of SR-74 from 200 ft. south of the intersection of SR-74 and Canyon Crest Road, traversing northerly to the ending termini of SR-74 at current Reference Post 6, mile point 5.687 a distance of 0.604 plus or minus miles be transferred to the jurisdiction of Alpine City Corp.
2. The Functional Classification of stated roadway will become Urban Collector in accordance to the newly defined Provo-Orem Urbanized Boundary location and placed on the Federal-aid System as a portion of route number 2906 for a distance of 0.604 plus or minus miles.
3. All other provisions defined within the afore-mentioned Agreement for stated Jurisdictional Road Transfer entered into between the Utah Department of Transportation and Alpine City Corp., hereby are declared viable and passage of this resolution, by this Commission, hereby justifies all statements defined within stated Agreement as defined by law.
4. These actions will become effective upon passage of this resolution by the Utah Transportation Commission.
5. The accompanying Jurisdictional Transfer Agreement and Exhibit "A", will be included and become part of this resolution.

AGREEMENT

THIS AGREEMENT, made and entered into this _____ day of _____, 20 ____, by and between the **UTAH DEPARTMENT OF TRANSPORTATION**, hereinafter referred to as "**UDOT**", and **ALPINE CITY CORPORATION**, a Municipal Corporation of the State of Utah, hereinafter referred to as the "**CITY**",

WITNESSETH:

WHEREAS, CITY desires to take control ownership and responsibility of the section of SR-74 from 200 feet south of the SR-74/Canyon Crest Road intersection to the SR-74/200 North intersection in Alpine City, Utah County, Utah under **UDOT** Project No. SP-0074(2)5; and

WHEREAS, UDOT desires to cede to the **CITY** said portion of SR-74 referred to above, subject to the approval of the Utah Department of Transportation Commission and Utah State Legislature; and

WHEREAS, UDOT is willing to provide the **CITY** with funds in the lump sum amount of \$170,000.00, which includes \$20,000.00 for new street lighting facilities, to make improvements on said portion of SR-74 under the conditions set forth herein. Additional street light facility funding will be handled as matters separate and apart from this agreement; and

WHEREAS, CITY desires to begin work on SR-74 improvements immediately while the process of changing ownership of this section of roadway is being processed; and

WHEREAS, UDOT has determined by formal finding that payment for said work on public right of way is not in violation of the laws of the State or any legal contract with the **CITY**.

THIS AGREEMENT is made to set out the terms and conditions whereunder said lump sum payment shall be made.

NOW THEREFORE, it is agreed by and between the parties hereto as follows:

1. The **CITY** will take over control and responsibility for the above referenced section of SR-74, including all necessary maintenance, effective on the date herein above written, subject to the terms and conditions contained herein; and

2. **UDOT** will provide the **CITY** with funds in the lump sum amount of \$170,000.00, which includes \$20,000.00 for street lighting facilities, to be used for improvements on **CITY's** newly acquired portion of SR-74 upon the completion of the right of way ownership transfer documents and this agreement being put in place and effect.

TOTAL LUMP SUM PAYMENT TO CITY IS \$170,000.00

3. **UDOT** agrees to allow the **CITY** to immediately proceed with construction of improvements to said portion of SR-74 under the condition that, to the extent that **CITY** may lawfully do so, **CITY** agrees to relieve **UDOT** from any responsibility or liability that may result from their new improvements or operation thereof.

4. In the event there are changes in the scope of the work, extra work, or changes in the planned work covered by this agreement, a modification to this agreement signed by representatives of the parties hereto is required prior to making said changes or additions.

5. The **CITY** has previously applied for safety sidewalk funds in 2003 to replace some substandard side walks that are within the portion of the roadway that the **CITY** proposes to take over. **UDOT** shall allow the **CITY** to continue to apply for these funds, with equal treatment to other state roads, to improve the safety of these areas.

6. Upon receipt of a fully executed copy of this agreement and right of way ownership transfer documents being completed, the **CITY** will send a bill bearing **UDOT's** Project Number, in the lump sum amount stated herein to: **UDOT's** Office of Construction, **UDOT/DPS** Complex, 4501 South 2700 West, Salt Lake City, Utah 84119-148220, Attention: Contracts, Estimates and Agreements Supervisor. **UDOT** will then process said bill and make payment within sixty (60) days.

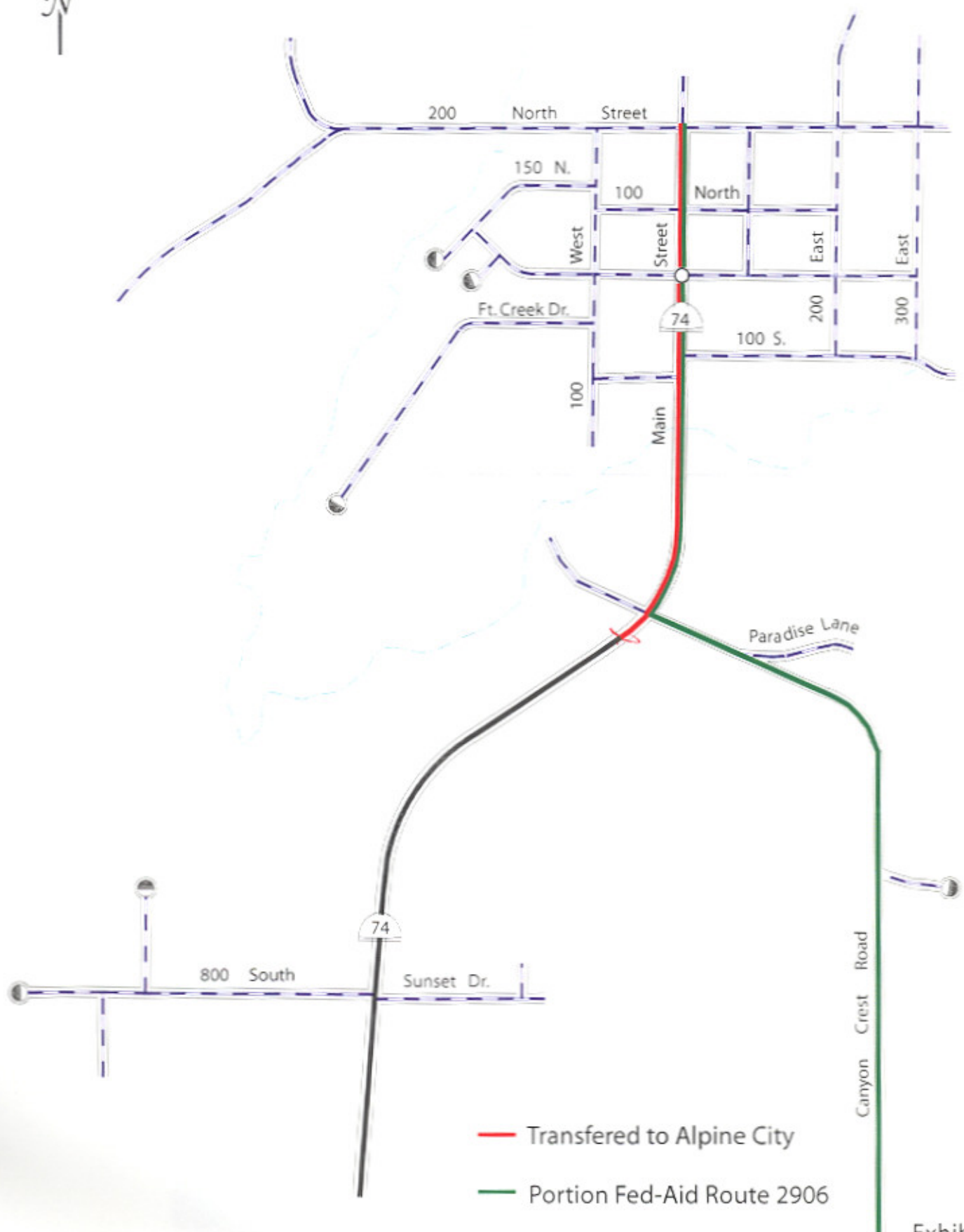
