RESOLUTION

State Route 183-A

WHEREAS, Ogden City has requested the State Road Commission to place 12th Street in Ogden City, Weber County (from Washington Avenue easterly to Harrison Boulevard), on the State Highway System in exchange for the deletion of 7th Street (State Route 183-A) in Ogden City from the State Highway System; and

WHEREAS, such addition and deletion will comply with the minimum qualifying standards for such action as established by the State Road Commission; and

WHEREAS, such addition and deletion is felt to be in the best interest of the traveling public and the State of Utah;

NOW THEREFORE, pursuant to the authority of Sec. 27-12-27, UCA 1953, as amended, it is hereby resolved as follows:

1. That State Route 183-A (7th Street, Ogden, Utah) be deleted from the State Highway System, and jurisdiction thereover relinquished to Ogden City.
2. That 12th Street in Ogden City, from Washington Avenue (State Route 1) easterly to a connection with State Route 203 on Harrison Boulevard, be placed upon the State Highway System and designated as State Route 205.
3. That this action of addition and deletion to the State Highway System is interim only and direction is

herewith made that same be submitted to the next regular session of the State Legislature for approval or disapproval.

- 4. That as a result of this action the mileage on the State Highway System does not increase or decrease because this is a transfer of road mileage of the same length.
- 5. That Exhibit "A" attached herewith, illustrating the action taken herewith, is hereby incorporated as a part of this Resolution.

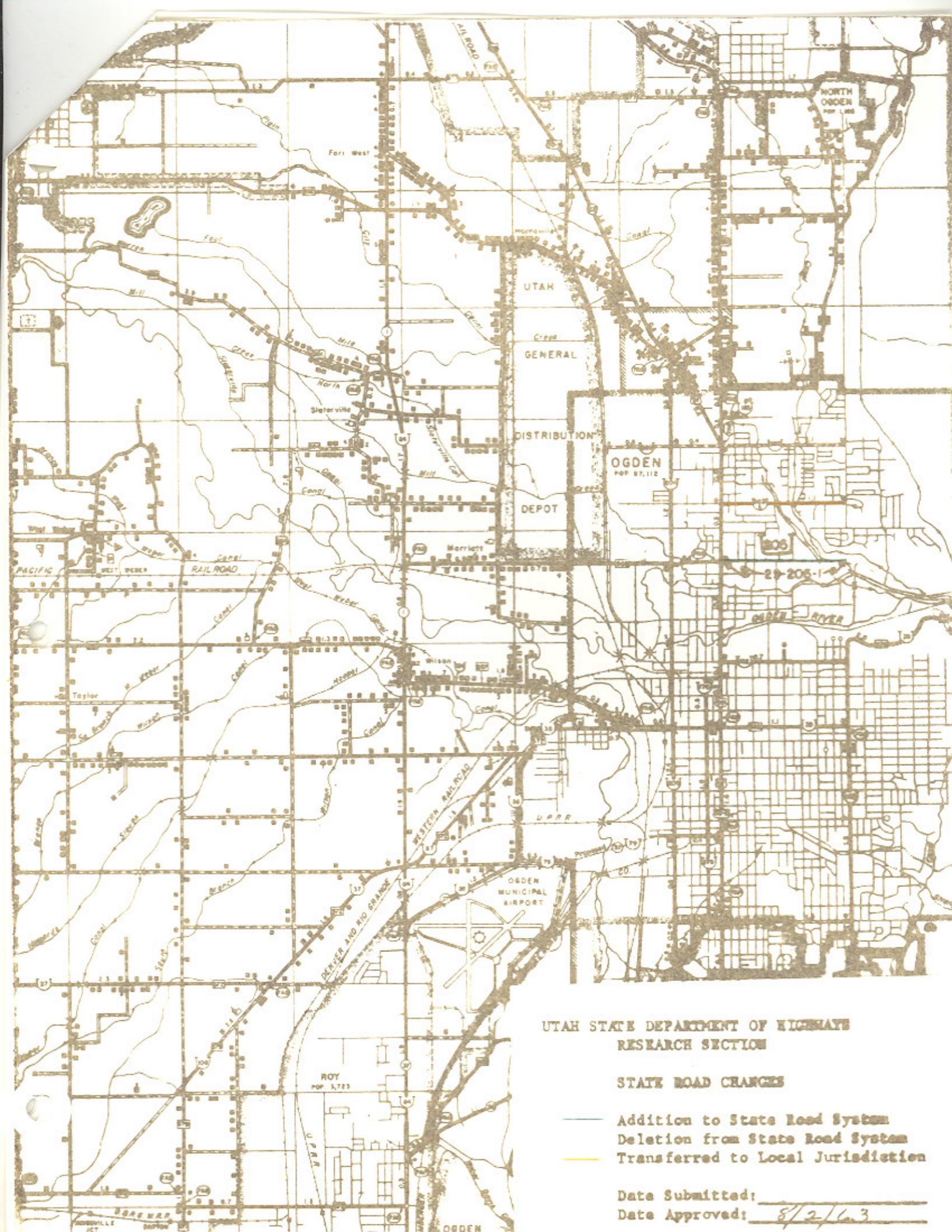
