WHEREAS, Section 63-11-20, Utah Code Annotated, 1953, as amended, relates that: "All roads connecting state parks with federal, state or county highways or city streets where the title thereto is in the state are parts of the state highway system and are to be maintained by the state. The state road commission is authorized to construct and maintain roads within state parks subject to approval of locations and design by the commission through its director", and

WHEREAS, it is the desire of the Utah State Road Commission and the Utah State Division of Parks and Recreation to define responsibility for the administration of roads at state parks, and

WHEREAS, it is agreed between the State Road Commission and the State Division of Parks and Recreation that certain roads meet the criteria set forth in Section 63-11-20, UCA, 1953, as amended, and

WHEREAS, those roads at state parks that are part of the State System of Highways should be identified by a number.

NOW THEREFORE, in accordance with Section 63-11-20, UCA, 1953, as amended, it is hereby resolved as follows:

That the roadway from the parking area at the marina of Willard Bay North State Recreation Area northerly to 750 North in Willard, thence east to State Route 84, a distance of 1.73 + - miles be identified as State Route 315,

That the memorandums from Mr. Harold J. Tippetts, Director, State Parks and Recreation, and Mr. Bert L. Taylor, District #1 Engineer, relating to the subject road be hereby incorporated as a part of this submission,

That the maps attached illustrating the action taken herewith and the location of Willard Bay State Park be hereby incorporated as a part of this submission.

In connection with the construction of subject project, "C" line from SR 84 to the west side of the Willard Interchange (5,021 ft.) and "L" line, from the west side of the Interchange to its beginning (3,355 ft.) have now been paved. In addition to these two segments, a previously constructed roadway from the beginning of "L" line to the parking area of the State Park marina (750 ft.) would complete a new route (9,126 ft. or 1.728 miles) which this office feels should be placed on the State system.

Please advise as to whether or not this recommendation meets with your approval.

A field inspection has been made of the roads in Willard which were constructed with I-15. Bert L. Taylor, District One Engineer, has recommended the 750 North and the extension to North Willard Bay Recreation Area be designated as part of the State Highway System. It has been determined that the subject roadway could be included in the State System of Highways as an access route to the North Willard Bay Recreation Area.

You may recall that earlier discussions with your office concluded that the road from I-15 to Willard Bay should be a Park access road. Mr. Taylor's recommendation would extend State responsibility for the road all the way to SR-84. We propose to bring this matter before the Road Commission for action shortly.

Your comments on this action would be appreciated.

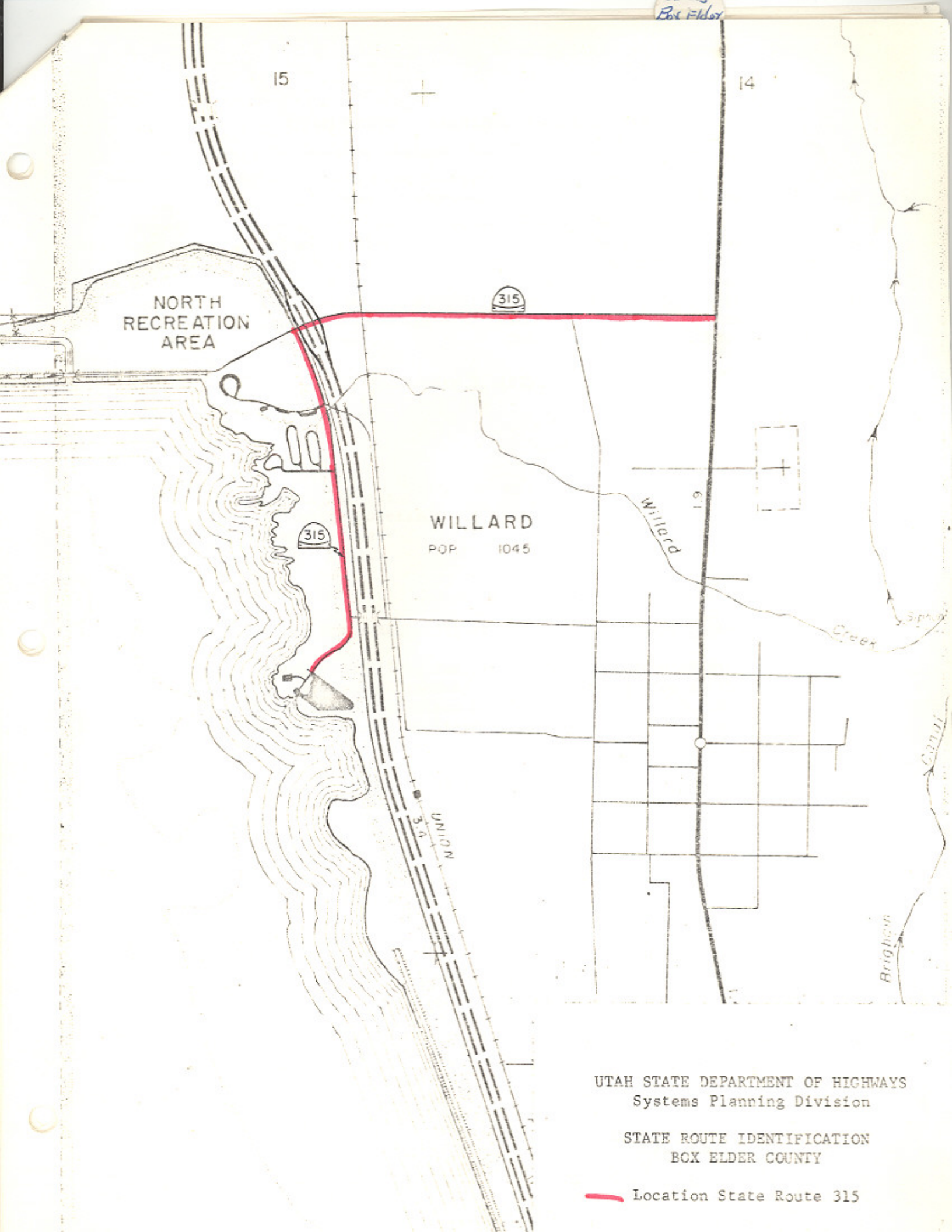
