



Unified Commercial Development (UCD) Revocable Permit Waiver Application

Application is hereby made under Utah Code § 72-7-504.6 for an outdoor advertising permit waiver in the outdoor advertising corridor. Only fully completed applications will be accepted, reviewed, and processed. All others will be returned to the applicant for completion. A nonrefundable application fee of \$950 is required to process the application. An electronic link to the controlling statute within Utah's Outdoor Advertising Act is available for review udot.utah.gov/go/UCDStatute. Failing to secure a revocable permit waiver when required may result in any existing sign(s) being considered as unlawful and subject to significant penalties as outlined in Utah Code Section 72-7-508 (up to \$1,500 per day for non-compliance).
