PROJECT SCOPE

The project will

- add or extend left and right-turn lanes
- add center-running raised medians
- add new signal equipment and adjust signal timing
- work with businesses and property owners to consolidate accesses









PROJECT PURPOSE & NEED – IMPROVE SAFETY

With over 2,700 crashes from 2013-2018, conditions on State Street in Orem are resulting in an average crash rate of approximately *one crash per day*. The State average for a similar roadway type is closer to *one crash per week*.

Proposed project improvements will address crashes as follows:

- Center Street 51% reduction (15 rear end and 6 angle crashes)
- **800 North** 50% reduction (20 angle crashes)









PROJECT PURPOSE & NEED – IMPROVE MOBILITY

Traffic is projected to increase by 20% in 2025. Making State Street more efficient, safe and predictable is an important priority for Orem City, business and property owners along the corridor and motorists throughout the City.

Proposed project improvements will address mobility as follows:

- Center Street reduce intersection delay by 15% (approx. 23 seconds)
- 800 North extended turn lanes will provide more space for turning vehicles outside the travel lanes, improving through traffic flow.

PROJECT BENEFITS

SAFETY

Raised medians and other project features can help reduce crashes and create a more predictable environment for drivers by:

- centralizing left-turns
- consolidating driveway accesses
- extending turn pockets to get drivers out of travel lanes

MOBILITY

The project improvements include:


- more space for turning vehicles outside the travel lanes
- dedicated left-turn access points
- optimized traffic signals so that vehicles can move more efficiently and predictably at both the Center Street and 800 North intersections.






CENTER STREET AREA CRASHES
