


Purpose and Need of the Project

- Purpose
 - To provide east-west mobility across U.S. 40 in the area of the Mayflower exit between MP 6.85 to MP 8.8

- Need
 - Provide additional ingress/egress points to enhance life safety
 - Reduce congestion at the Mayflower Interchange
 - Provide opportunities for active transportation and recreational access across U.S. 40

- Military Installation Development
 Authority (MIDA) facilitates the
 development of military land in
 Utah to help stimulate the State's
 economy
- State legislature approved the development of under-utilized military land in this area west of U.S. 40 to boost the economy of surrounding communities






Proposed Action

- Addition of two U.S. 40 undercrossings to provide local traffic access improving connectivity and providing access for life safety
- Construct bridges to accommodate anticipated traffic volumes
- Build bridges to accommodate a future climbing lane as noted in Statewide Transportation Improvement Plan (STIP)





Project Map

Environmental Impacts and Mitigation

Resource	Impacts	Mitigation
Right-of Way/Relocations	Minor acquisition for drainage easements will be necessary.	If we determine that a ROW easement is necessary we will purchase the necessary easement prior to work starting.
Cultural/Paleontological	None	
Threatened and Endangered Species/Wildlife	One osprey nest is known to exist near the southern end of the project area.	In order to minimize impacts to nesting osprey, it is recommended that work begin before April 1 or after August 31. If work cannot begin before or after that time period, a nest survey should be conducted to identify active nests within 0.5 mile of the project area. If active nests are found, work should be avoided within 0.5 mile, or the nest should be monitored to ensure that construction activities are not negatively impacting nesting birds until all young have fledged.
Wetlands, Water Resources, Storm Water and Floodplains	Project disturbs 1 acre or more of ground surface.	A Storm Water Pollution Prevention Plan (SWPPP) must be included in the plans.

Air Quality	This project has the potential to increase particulate matter due to construction activities.	Requirements outlined in Standard Specification 01572 titled "Dust Control and Watering" will be followed.
